## **The Rules of the Brooklyn Water Ski Club Incorporated**

1. The following rules 2 to 30 inclusive, take precedence over any conditions either expressed or implied as contained in the Constitution.

The Club shall mean the Brooklyn Water Ski Club Inc. (BWSC)

The Committee is deemed to mean the officers of the club as elected at the BWSC annual general meeting.

A 'member' is a senior financial member of the BWSC Club.

2. Members when using the club or the clubs equipment shall give consideration to all the rules of the club. It shall be the responsibility of the individual members of the club, and their visitors to understand these club rules, and the bylaws and rules for using Lake Karapiro.
3. The Club will not accept any bookings for Sundays and has reserved this day for Members only.
4. Club days shall be held on any special days duly notified by the Committee.
5. No dogs are allowed on Club property at any time.
6. Vehicles when used at the club shall be done so in a safe and considerate manner. Speed on driveway shall not exceed 20kph.
7. Vehicles shall be parked in the designated parking areas, and free of the beach and lower lawn areas.
8. Boat trailers shall be parked in either of the two designated trailer parking areas adjacent to the boat ramp. No trailer shall be left on the ramp or drive way areas.
9. When using a boat at the club, members must ensure that they comply with each and every club rule and the appropriate national and regional regulations relating to appropriate and safe boating at all times.
10. No person under the age of 15 years shall be in charge of, or propel or navigate a power-driven vessel that is capable of a proper speed exceeding 10 knots, unless he or she is under the direct supervision of a person over the age of 15 years who is in immediate reach of the controls, and who is not the lookout person as provided for in clause 10
11. and, that at least one other person is on board who is 10 years of age or older and responsible for immediately notifying the person in charge of every mishap that occurs to the person and/or object that is being towed.
12. All boats must display a 'current' BWSC membership sticker and allocated club number.
13. All boats must leave and drop off skiers in the designated ski lane(s).
14. Boats leaving the shore must give way to boats landing a skier.
15. No boat in the take off area shall leave the towlines trailing in the water.
16. Swimming shall only be permitted in the signed swimming area.

17. Members shall have the privilege of introducing visitors, but the visitor shall not be introduced more than once a month except on guest days unless at the discretion of the Committee. Guests of children being part of a family membership are exempted from the provisions of this rule.
18. Should a member wish to bring more than 8 guests to the club at any one time, the prior approval of the committee is required.
19. With prior approval, the club is available for private hireage on non club days. In such situations, an adult club member shall be responsible for hosting the visitors.
20. Members shall still be permitted to use the club grounds when a private hireage has been arranged.
21. Camping is permitted at the club with prior approval. Camping is permitted at the northern end of the grounds as indicated on the club maps. Unless approval is provided by the Committee, no persons shall sleep in the club buildings.
22. Such fees for hireage and camping shall be determined at the Annual General meeting and collected at the discretion of the Committee.
23. Members are permitted to use the club ski equipment at any time. No member is permitted to take such equipment away from the club without prior approval of the committee. Members using club equipment are responsible for ensuring that it is returned to the storage area in a safe and undamaged state. If equipment is damaged or unsafe, then they shall be responsible for fixing any breakage. Members shall pay the full cost of replacing any club property destroyed, damaged or lost by them.
24. No petrol or other dangerous substance shall be stored in the Clubhouse with the exception of nominal supplies stored for the motor mower, BBQ and the like.
25. Members are discouraged from leaving/storing personal belongings in the club rooms. If equipment is left at the club, BWSC is in no way responsible for any loss or damage which may occur to such equipment which is left at the club.
26. No junior member is permitted to use the club facilities without the supervision of a senior member.
27. The last person leaving the Club grounds is required to ensure the Clubhouse and gates are securely locked.
28. All members are responsible for removing from the club any waste they have generated from their stay. No rubbish is to be left at the club. Use bins provided
29. The BWSC discourages the consumption of excessive alcohol at the club. Any person consuming intoxicating liquor on Club property at any time may, at the discretion of the Club Captain, any Committee Member or members at large, be prohibited from taking part in club activities. If considered advisable by not less than three members at large present, any liquor in that person's possession may be confiscated and returned to the member at a later date.
30. Smoking is not permitted in the club buildings. It is recommended that vaping and smoking is adhered to on the upper terraced areas away from Members.
31. The committee may from time to time decide to overrule the above club rules on the grounds of a one off special event. The committee shall be responsible for recording such decisions and as appropriate notifying members of such decisions.

## Indemnity

I/We confirm that by making payment of our invoice and/or renewal of your membership to Brooklyn Water Ski Club Limited that acknowledge and accept the terms and conditions of membership including but not limited to the indemnity of the club and the committee members against any claim.

### **Definitions**

The parties referred to in these terms and conditions are set out as follows:

**The Club** means the Brooklyn Water Ski Club Limited, BWSC

**Member** means the person or persons who have signed the application form to become a Member, their family, friends, invitee's and guests that are attending the Club with the Member at any given time.

**Committee**– Any past, present or future committee member including but not limited to the President, Vice-President, Secretary, Treasurer and Club Captain.)

**Events** – Events are defined as an actively enforced or promoted by the club.

**Property** - includes any property owned by me or in my possession or under my control.

1. The Member is aware that any water sport (including but not limited to Water Skiing, Wakeboarding and Boat Racing) involve the possibility of injury or death and a risk of damage to the members property.
2. The Member acknowledges that the rules and safety precautions of the Club **must be followed and that sole responsibility of the Member's personal safety and their property remains with the Member.**
3. The Member will not make any claim against the Club, the Committee, Agents, representatives or partners in respect of any injury to the Member or damage to the Member's property.
4. The Member hereby indemnifies the Club and the Committee against all claims, damages or losses (including costs) that the Member may incur as the direct or indirect result of injury to the Member or damage to the Member's property.
5. The Member further indemnifies the Club and the Committee against all claims, damages or losses (including costs) which the Member may incur at any Event.
6. The Member acknowledges and agrees this indemnity will be binding on the Members legal assigns, administrators and executors.
7. The Member acknowledges that the Club and the Committee recommend that the Member has insurance for their Property and the use of the Member's Property will be used at the Club at the Members sole risk and cost.
8. Any additions or alterations to the terms and conditions of this agreement shall be null and void unless agreed by in writing by all parties.
